AI-powered right-place, right-time, self-directed reflective learning

Statement of Need

This activity helps address certain relevant blind spots within the clinicians' clinical, administrative and personal day-to-day practice, while learning how reflective practice can be applied to themselves and their peers. This is accomplished via an awareness engine that surfaces nudges at the right place and right time for clinicians to engage and reflect. The clinician is prompted to reflect upon how the surfaced content within the nudge applies to their day-to-day. This reflection is captured in their learning journal allowing to serve as both a reference for the learner and a nudge to share with their team.

Learning Objectives

<u>Clinical</u>: Learners, as a member of a team, will be able to summarize clinical risks and blind spots in their practice setting.

<u>Administrative</u>: Learners, as a member of a team, will be able to identify administrative risks and blind spots in their practice setting.

<u>Reflective thinking and application</u>: Learners, as a member of a team, will be able to summarize and analyze an idea, clinical relevance or a professional impact to performance or clinical outcomes within their practice.
